Bachelor degree in Commerce preferably majoring in Accounting and Auditing or equivalent qualification, a postgraduate qualification will be an added advantage; a sound understanding of youth development; a good understanding of the Free State Youth Commission Act no 4 of 1996, as amended by Act no 1 of 2001; experience in Finance and Human Resource are essential for this position. The candidate must be computer literate and possess a valid driver's license; the ability to work under pressure are also essential.

Responsibilities

The candidate will be responsible to manage the Finance and Human Resource Business Unit. Prepare monthly financial statements. Prepare monthly accounts and reconciliation.
